Meeting with National Sports Federations (NSFs)

A meeting in the office of NADA was convened on 17th March 2020 under the chairmanship of DG NADA with officials of SAI and NSF to discuss the progress status of dope tests and anti doping education program for the upcoming Tokyo Olympic Games. During the meeting, various issues with regard to dope testing of Olympic core probables were raised and current status of dope testing done for core probables by NADA wef July 2019 till date was appraised. It was desired that concerned NSF may share the whereabouts details of those sportspersons who has been frequently training outside country and not recently tested by NADA so that dope testing of those players may arranged at training locations/ respective country or whenever or wherever they are in India. Representatives of NSF were also requested to share their annual calendar of sports event/ training for 2020-21 to enable NADA to prepare its annual dope testing plan as per WADA guidelines.
