The Anti-Doping Appeal Panel (ADAP)

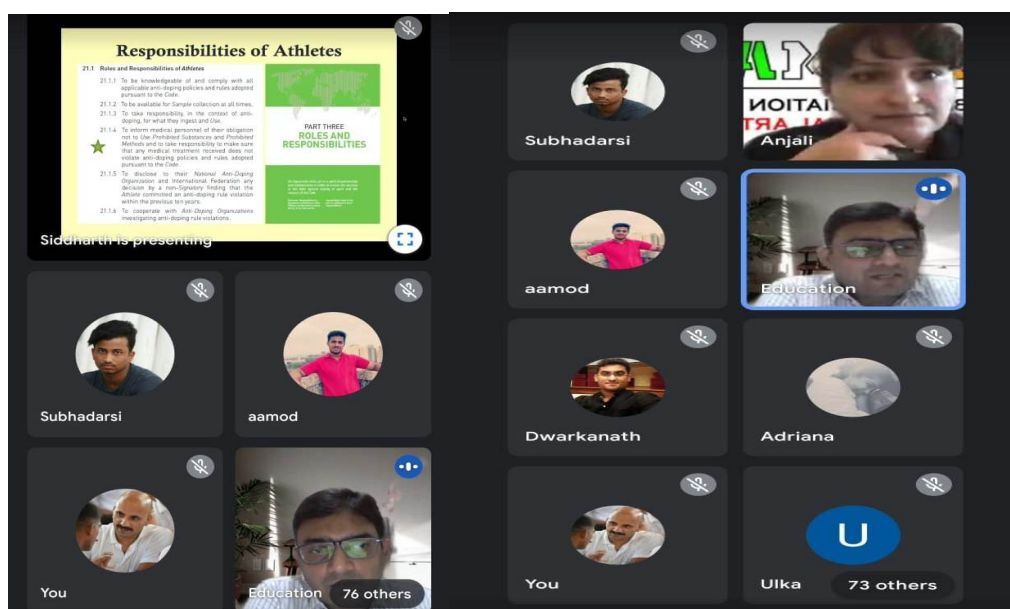
